#### **General**

Your information is, of course, collected and processed in accordance with legal regulations, particularly Germans' Federal Data Protection Act and Teleservices Act. To use a GBS application, you will be required to register or log in. We need these data in order to, among other things, enable access and support and to facilitate individual services.

#### **Consent/Revocation/Objection**

By registering, you consent to our collection and saving of inventory, usage, and content data and our user of that data to improve our products, customer service, and assessment of user behavior. If you have consented to this use of your data, you may revoke that consent at any time via email to [info@gbs.com](mailto:info@gbs.com) or in writing to GBS' address. If you should revoke consent, however, you may no longer be able to use the product. Objection is free of charge (with the exception of transmission costs that may apply to you).

#### **Conveyance of Your Data to Third Parties**

We will not, under any circumstances, give the information we collect on your user of our digital products to third parties.

#### **Technical Security**

We continually update our technical and organizational security measures to protect the data that has been conveyed to us. These measures are intended to prevent unauthorized access, unlawful deletion or manipulation, and accidental loss of data to the greatest extent possible.
